

**MINUTES OF WAPAKONETA CITY BOARD OF EDUCATION
REGULAR SESSION
WAPAKONETA ELEMENTARY SCHOOL
Tuesday, January 12, 2021
7:15 PM**

The meeting of the Board of Education of the Wapakoneta City School District was called to order by President Joshua Little.

The Pledge of Allegiance was led by Joshua Little, Board President.

BOARD MEMBER RECOGNITION

Mr. Aaron Rex, Superintendent, said a few remarks about all of the Board Members. These remarks are included as part of his report attached to the agenda.

RETIREE RECOGNITION

Retiree Recognition - Recognize the following retirees:

CHERYL ERB - Bus Driver since November of 1995

TODD GERSTNER - Custodian since June of 1991 and Maintenance since 1993

Mr. Aaron Rex said a few remarks regarding each retiree and congratulated them on their retirement. Both have been rehired by the District so they were also welcomed back.

Mr. Mike Watt also said a few remarks about the retirees. He stated that during Cheryl's career she worked with a lot of students with special needs, which takes a certain kind of person. He thanked her for all of her years of service. Mr. Watt stated that Todd took on the role of

Maintenance Supervisor five years ago. He was a little reluctant at first, but has done a great job. He has built a good rapport with staff and students. He thanked Todd for his leadership.

Mr. Little presented both retirees with a gift from the Board of Education and thanked them for their years of services.

EDUCATIONAL REPORTS

Mr. Aaron Rex stated that it has only been eight school days since the last time administrators shared a report with the school board. He said that if they wanted to share one thing that has happened since then, they are more than welcome to.

Mr. Jason Wolke stated that since the last meeting there have been a lot of assessments going on. He wanted to thank Carrie for all of the reports she has put together for the administrators. They are getting a lot of information and diving deep into it right now. Today the District enrolled the 107th new elementary student for this school year. It is a kindergartner. We are still growing and the future looks bright for Wapakoneta City Schools. Mr. Sammetinger asked how many students the District has lost since the start of the school year. Mr. Wolke was not sure of the answer, but he knows that it has been a net positive gain.

Mrs. Nikki Sutton would like to celebrate that Wapakoneta Elementary has kids in school five days a week. She also wanted to mention that the kids are glad to be here as well and that this year they did not have any transition issues coming back from break. She appreciates what everyone is doing to keep our kids in school.

Mr. Will Snyder stated that this is the last week of the nine weeks. He mentioned that they are celebrating their PBIS award winners this week. He briefly described the PBIS system that Mr. Cutnaw has implemented at Wapakoneta Middle School. He also mentioned how wonderful the new health department standards are with quarantines. He stated that they have had several positive cases this week, but they haven't had to take as many kids out of the classroom.

Mr. Aaron Rex stated that he took a tour of the PBIS rewards store. He indicated that many people have donated items towards it. Mr. Snyder mentioned that the goal is to earn the bronze status after the first year of implementation. Wapakoneta would be the only school in the county to achieve this status. If it doesn't happen this year, it should happen next year.

Mr. Scott Minnig stated that last Thursday they had a meeting at the high school with the new student council social group. It gave students the opportunity to speak up about issues in the school that administrators may not see. There were 27 students from all grades and all subgroups in the building at the meeting. They and the members of the Gatekeepers Club worked together to come up with a slogan, "Wapak Way," in order to create a culture of respect. Some of the items they felt were the biggest concerns in the building were mental health, supervision in the bathrooms, students wearing masks correctly, technology access at home for some students, and how kids interact with one another appropriately and inappropriately. This information was compiled and then shared with the entire student body. They were asked to vote on what they thought was the most glaring issue in the building. Of the 185 students who responded, 54% stated mental health was the biggest issue. Mr. Minnig said they will take this

information, meet monthly as a group, and work together to come up with the solutions for the issues they face.

Mr. Aaron Rex brought up the concern regarding supervision in the bathrooms. He mentioned that the concerns arose because of students possibly vaping. Mr. Rex isn't sure that parents understand how big an issue vaping really is. He stated that the District has always struggled with supervising the bathrooms. For one thing, you can't put cameras in there because it is illegal. Staff does not have the time to go stand in the bathrooms to monitor them between classes. They are generally out in the hall monitoring the activity there or getting stuff ready for their next class. It is something they will continue to work on. He liked how the students are being proactive and trying to change these things. He stated that we do a really good job here at Wapakoneta City Schools, but we should always be asking how we can get better.

Ms. Carrie Knoch stated that preschool registration is rolling in quickly. She stated that we are in a position that people may not get their first choice. There is still plenty of room for students, but spots are filling quickly. She also mentioned that the District tracked pretty carefully how many of our students were quarantined from being exposed to a positive case and then ended up being symptomatic or testing positive themselves. She stated that it was less than 5%, so what the staff and students are doing in the buildings is working.

Mr. Mike Watt stated that this week the District got some good news from the City of Wapakoneta. They are going to start offering some LED incentives, which will be good as we change out the lights at Wapakoneta Middle School this coming March/April and then Wapakoneta Elementary School after that.

Mr. Brad Rex thanked Caitlin Helmstetter for her reaction to a student from Fairview High School having seizures during the big wrestling tournament that was held at the high school this past weekend. She handled it very calmly. He also thanked the City for their quick response with an ambulance. Mr. Rex spoke to the mother of the young man and he is okay.

Mr. Aaron Rex thanked Brad for following up with the mother, which he knew helped ease her mind. He wanted to point out that this is an example of how our employees are going above and beyond.

- I recently spoke with our Career Counselor, Laura Mears. She stated that our 8 students in the STNA program have all completed and passed the course in our partnership with Rhodes State. They will now move on to the state board exam. There will be 8 more students starting the course during second semester. We have had multiple students take part in the internship program first semester and there will be approximately 40 more getting this experience the second half of the year. They have been in areas such as police work, accounting, skilled labor, law, veterinary work and more. We have received a lot of positive feedback and see the program growing.
- We were able to do some of our classroom walkthroughs at the high school once we returned from break. I say this every time, but it is always enjoyable to see the teaching and learning taking place in our classrooms.
- As you know the district submitted a bid for 8 acres of land on the south side of Redskin Trail near the softball field. Our bid for this strip of land was not accepted as another individual purchased the entire property.
- This month is school board recognition month. I would like to recognize and thank our school board members for their leadership and dedication to Wapakoneta City Schools. New Elementary Students to Wapakoneta

Each year at this time, I begin to notify the board about the growth we are seeing in this district at the elementary level. To date, we have added 101 new students to our classrooms. Not all of the 101 are brand new to the district, but well over 95% are. Some of these students were unenrolled at the beginning of the year due to COVID restrictions and were homeschooled. At the halfway point of the school year, several of these parents have enrolled their children back with Wapakoneta City Schools. I believe that at no other time in the lives of anyone living, have we understood the importance of learning in a classroom with a teacher. Thank you to everyone in this room for making this happen at WCS.

Guys in Ties

We are up and running again! I have personally met with each grade level and discussed with them the plan of meeting and topics. As this has turned into something in previous years that has gained a lot of traction, another "group" has also started at CES. Girls in Pearls will be very similar to Guys in Ties in that they will have topics focused on being Respectful, Responsible and Kind. Aundrea Brown, Cori Fields, and Jill Stubbs will be leading these groups.

Together we are creating a schedule so that when the girls are with them, the boys can come with me or whoever is working with the boys that week. In the past, Mr. Rex and Mr. Watt have agreed to speak with them. This year I thought it would be great for Mr. Cutnaw or Mr. Snyder to lead a session about Middle School expectations. We will work on this closer to the time of delivery.

Returning Students from Online

At the beginning of the school year, 50 students from Cridersville Elementary School had families choose to do online schooling rather than send their student to school. Shortly after the school year started, that number was reduced to around 25. At the end of the first nine week grading period, this number was reduced a little over half again. At the end of the second nine weeks, CES has only 6 students that will remain online. Now some of you might say, "That's because the parent needs a break." I say, "We're just that NEEDED!"

SEL and Guidance

I have spoken on the addition of the SEL position in the past but just wanted to take a moment to reiterate the important job Mrs. Fields is doing. Carrie Knoch as my witness, our preschool rosters have taken a sudden increase in number, but have exponentially increased in needs and supports. Having the addition and support of the SEL has proven to be worthwhile for student and family. We will continue to grow this program in the hopes that Mrs. Fields can become permanent at CES.

Preschool enrollment for 2021/22 opened on Monday. Packets can be picked up at the Board Office. Once the packet is returned, we will place them on a waiting list. New students will be added to classrooms in late February/early March when we have a good idea about the intentions of current students. In the last few days, we've had a GREAT response and already probably have 20 on a list!

Kindergarten Registration will be online this year. It worked well last year this way. This also gives the parents a little more flexibility with time and keeps the Board Office staff safer without so many visitors. Here is the information if you are asked:

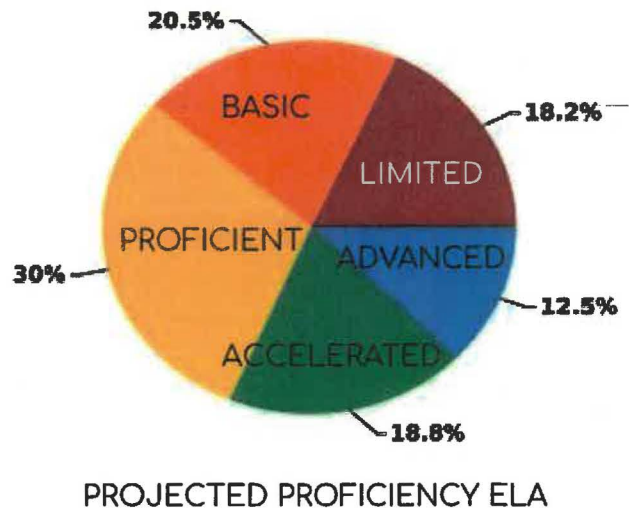
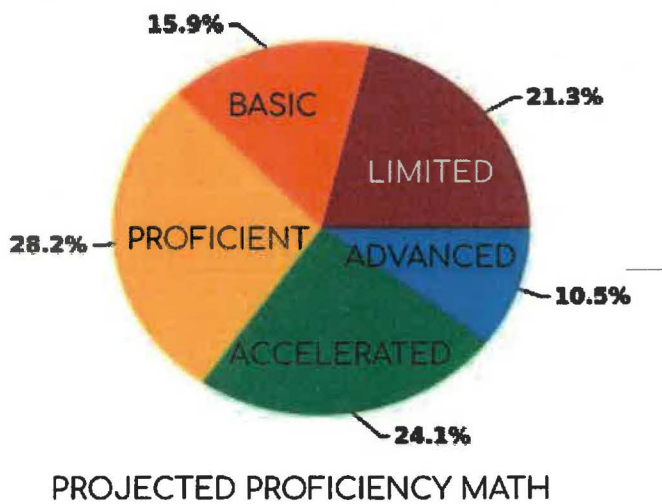


Celebrations:

- Geometry is an area with relatively strong performance in math in grades 2-4 over several years

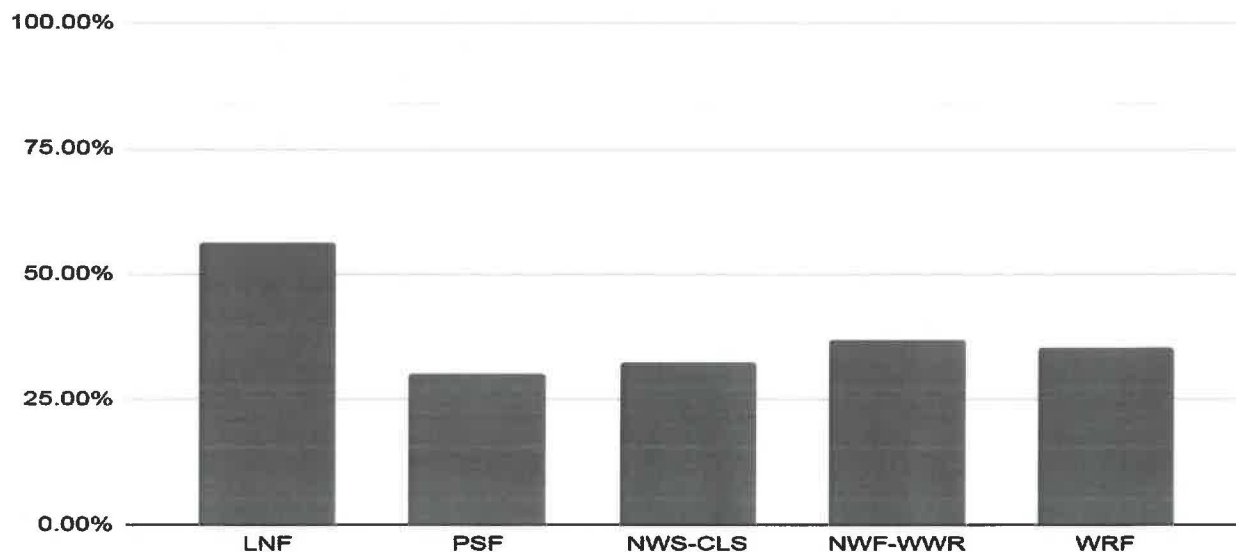
