- Our second nine weeks ends on January 17 and the teachers will have a work day on that Friday. The students will return on January 21 for the second semester of our school year. I am excited to see all that will take place!
- During our break I was able to speak to a few students who were home for Christmas.
 While visiting they told me of how they were able to graduate in less than four years due to our college credit plus program. Some of these young people did attend four years, but were able to get their Master's degree during that time. I am proud of the programs that we offer for our kids and the impact that they have on their future.
- We have been working on our Winter Redskin Report. This will be the second one we have created with the online version. - We currently have 41 students enrolled into virtual school as of Wednesday January 8th.
- We currently have 8 students taking three or more classes on-line as of Wednesday January 8th.
- We currently have 17 Seniors, 12 Juniors, 6 Sophomores, 6 Freshman enrolled into virtual school as of Wednesday January 8th.
- · We currently have 76 classes scheduled at this time.
- We are currently serving 8 students on an IEP or 504 plan.
- We currently have 8 students involved in our credit recovery program at this time.
- We will continue to make communication a priority with our students. Every student will receive an email with a video attached explaining the expectations and how to navigate the program.
- We continue to contact parents to update them about their child's progress and grades. Parents can have the ability to become an observer to access their child's progress and grades if they have signed up online.
- Our guidance department receives weekly progress updates on all virtual school students and has been active in communicating with families.





Jason Wolke, WCS Director of Opportunity School Board Report January 2024

Opportunity School has continued to work with students to not only improve their education, but to also build life skills, so they can enter the workforce immediately upon graduation. With the weather changing, we will be moving most of the lab work inside. Over the district's Christmas break, I had several community members reach out to me to see if the students can assist them in providing some kind of service. Thank you to Jim and Tony Stinebaugh for trusting us with some of your equipment, and thank you to Jessica Rich for including the OPP students to join them in creating a Wapakoneta Community Garden located by Heritage Park. Construction on these projects will begin following a public meeting at the Library on January 28 at 5 p.m.

JUVENILE PROBATION COLLABORATION

Opportunity School and the Auglaize County probation officers will be partnering up to provide a positive incentive program for students in OPP school. Discussions are still taking place with the probation department. A meeting has been set up to finalize the finer points of this project so that it can be unveiled at the start of the second semester.

ACADEMIC SUCCESS

As of January 8, there are a total of 23 students in OPP school that are currently assigned and taking Semester B courses fully. There are four students that still have at least one Semester A course that is not completed. Of these four students, two have been incarcerated and the other two are students that have joined us later in the school year. By joining us so much later, their time to complete all the assignments has significantly been reduced; therefore, putting them at a disadvantage.

At the start of the new semester, we will have new students from the high school joining us. This change of date has been made so that the students are able to receive the credit from their classes in the first semester at the high school, and then start here at OPP school with a fresh start in the second semester. We are excited to welcome our new students, so that we can help provide a new opportunity.

THANK YOU

We would like to thank Ms. Jamie Buell for coming in to discuss with our Sophomores the opportunity to attend Apollo Career Center starting next year. With this presentation, I will be taking the Sophomore class to the 411 Blast they are offering on January 31. This will help provide them additional guidance into a career after high school, beyond what can be done here at OPP school.

Wapakoneta High School Board Report:

With the end of the first semester on January 16, it is an exciting time for many of our students because they will begin some different classes for the second semester. Some of these classes include Physical Education, Health, Ceramics, Digital Photography, Marketing, Computer Applications, Creative Writing, Cultures, Home Maintenance, History of Pop Culture, and Psychology. Power of ICU: As of January 10, WMS students had completed 1,263 assignments that were either initially not done on time or assigned while the student was absent. In the past or at other schools, these assignments may have ended up as a "zero" in the gradebook. The staff has committed to having every student complete every assignment.

MAP Data: In December, students completed their MAP tests for the winter. During TBT meetings, our teachers evaluated this data from their classes, identified students who made improvements, and set goals for the remainder of the school year to help students make growth. We also utilize this data to spot any schoolwide or grade level trends that may be affected by certain things we are doing as a school.

They have some very challenging behaviors in their classrooms, but have been incredibly flexible to meet the needs of their students. I appreciate how they are continually assessing and making changes to find the best way to meet their students' needs. They receive help from their paraeducators, Shannon Vickery and Georgie Cook. Another extremely important member of the team is Bethany Tenwalde, who does a great job providing additional interventions for at-risk students while providing veteran leadership for our intervention specialists.

2024-2025 AGREEMENT FOR PROVISION OF SERVICES BY THE ALLEN COUNTY EDUCATIONAL SERVICE CENTER

This agreement is made between the Allen County Educational Service Center Governing Board and the Wapakoneta City Schools for the provision of the following service by the Allen County Educational Service Center to Wapakoneta City Schools pursuant to R.C. 3313.843.

- 1. Allen County Educational Service Center will provide (ED) Pathway to Success Program Services as agreed upon by the Superintendent of the Allen County Educational Service Center and the Superintendent of the Wapakoneta City Schools during the 2024-2025 school year.
- Wapakoneta City Schools shall pay Allen County Educational Service Center \$175.10 per day/per student, for (ED) Pathway to Success Program Services for the 2024-2025 school year.
- 3. Wapakoneta City Schools shall pay Allen County Educational Service Center \$100.47 per session/per student, for Occupational Therapy Services for the 2024-2025 school year.
- 4. Wapakoneta City Schools shall pay Allen County Educational Service Center \$68.82 per day, for a One-on-One aide for the 2024-2025 school year as needed.
- 5. Wapakoneta City Schools shall pay the Allen County Educational Service Center upon receipt of an invoice. Once enrolled, Wapakoneta City Schools will be invoiced for everyday the (ED) Pathway to Success Program is in session or until the student withdraws.
