#### **REPORTS FROM THE BOARD**

Mr. Ron Mertz reported that last Thursday was the building dedication and open house for the Safety Training Center at Apollo. This building will hold the fire, EMS, and police officer training as well as the truck driving school. The total cost will be around \$10.3 million. Most of it was paid for with grant money. The classes in that building are full for next year, and all but four of the remaining classes on campus are already full for next year. They are looking at having 1,000 students enrolled next school year. The programs held in the new building also serve adults (fire and EMS). This is the first year they have offered a criminal justice program for high school kids, and it was well received.

- We have now entered the final nine weeks of the school year. I am looking forward to spring and all the activities in the classroom and our extracurricular activities.
- There has been a lot of positive feedback from our Wit and Wisdom training that has been taking place with our ELA teachers in grades three through seven. The trainer has been working with our staff which has allowed them to preview and plan for the learning modules for next year. I spent a few hours with our 7th grade teachers and heard a lot of good conversations and planning for instruction.
- After hearing from our parents at the last board meeting, we worked to arrange for all preschool students to continue taking advantage of the mid-day bus route. This means we will provide one route, either to school or home, during the middle of the day. We have received some positive feedback and this was a nice compromise to help our parents and also our transportation department.

March 2025

- Asphalt work is slated for the high school, bus lot and the Wapakoneta Elem School this summer. Cridersville Elem and middle school will be next year.
- 2025-26 Chromebook order has been received. Mark Law is working on getting them ready for the next school year.
- Chad, Alex and I have finalized our ERATE Category 2 items for this year. All have been evaluated and sent for review. This would include network switches, lockable/secure network racks (Cyber Security) and Network managed switches.
- Working with the Community Foundation (Greg Myers) in regards to a community concert event to be held at the PAC in April. 521 tickets have sold as of Friday....not bad for a first time.
- Varsity baseball and softball fields have been prepped by the maintenance staff and are ready for action. The middle school field dugouts should be completed within the next week. We are installing a tile along the front of the third base dugout due to a low area that retains a lot of water. This should be done this week.
- Tennis courts are slated to be resurfaced after the boys season is complete. The track should be up for a structural spray next year.
- The AC portion of the rooftops units at the high school makerspace area is supposed to start April 1.
- The PAC will be generating a lot of traffic in the next few months. We have a dance group from New Jersey this weekend and one from Ft. Wayne in May. Along with the many local dance recitals in June and July, we also host the summer moon festivities.

Wapakoneta Virtual School Grades 8-12

- We currently have 38 students enrolled into virtual school as of Wednesday March 19<sup>th</sup>.
- We currently have 12 students taking three or more classes on-line as of Wednesday March 19<sup>th</sup>.
- We currently have 19 Seniors, 6 Juniors, 5 Sophomores, 6 Freshman and 2 eighth graders enrolled into virtual school as of Wednesday March 19<sup>th</sup>.
- We currently have 97 classes scheduled at this time.
- We are currently serving 6 students on an IEP or 504 plan.
- We currently have 10 students involved in our credit recovery program at this time 4 of them are Seniors.
- We will continue to make communication a priority with our students. Every student will receive an email with a video attached explaining the expectations and how to navigate the program.
- We continue to contact parents to update them about their child's progress and grades. Parents can have the ability to become an observer to access their child's progress and grades if they have signed up online.

Wit & Wisdom's Module Study Coaching sessions are designed to support educators in implementing the curriculum effectively. These sessions provide indepth guidance on a specific module (unit), helping teachers understand its structure, key content, and instructional strategies. The coaches facilitated discussions on module texts, essential questions, and knowledge-building sequences while offering practical strategies for differentiation and student engagement. Teachers also explore assessment practices and collaborate to anticipate challenges and solutions. These coaching sessions aim to enhance teacher confidence, ensure fidelity to the curriculum, and ultimately improve student learning outcomes. These have made a tremendous difference for our teachers. We did 9 grade-specific sessions to keep numbers small enough that teachers could interact with the trainer and each other.

Opportunity School has continued to work with students to not only improve their education, but to also build life skills, so they can enter the workforce immediately upon graduation. Students have worked hard in the last month to make sure that their classes are at a minimum of 50% completed by the end of the nine weeks.

Over the course of this school year, 35 students have been enrolled in Wapakoneta's Opportunity School.

- 9 students have completed graduation requirements (these students are removed from the following data, leaving 26 students)
- 21 students are on pace to complete the requirements for this school year on or before the last day of school
- 10 students have completed this year's requirements and have started credits for next school year
- 129 courses have been completed in the three nine-week grading periods (both .5 and 1 credit classes)
- At the end of this board report, I have asked the students to share with you what about this program has been most impactful to them.

#### WAPAKONETA COMMUNITY GARDEN PROJECT

We are currently awaiting funding for this project through Jessica Rich. Once this funding is secure, we will assist with this as well.

#### **CURRENT PROJECTS...Continued and completed**

What an incredible February and March. Students were asked to create, design, plan, build, and finish a project of their own choosing. I was not disappointed in any way. Each of the students worked tremendously hard on this project, and the final results speak for themselves.

In early March, the projects were displayed in the classroom and a judging day was held. Judges included the staff, students, Officer Clark, probation officers, and Mr. Law. After scores were calculated, junior and senior students received credit towards their high school student engagement seal. A huge thank you to Mr. McElroy for assisting the students with equipment (laser engraver) that helped individualize each project for the students.






#### 5830 - STUDENT FUND RAISING

The Board of Education acknowledges that the solicitation of funds from students must be limited since compulsory attendance laws make the student a captive donor and since such solicitation may disrupt the program of the schools.

For purposes of this policy "student fund raising" shall include the solicitation and collection of money by students for any purpose and shall include the collection money in exchange for tickets, papers or any other goods or services. ("Approved School Organization" is any group whose goals and purpose have been approved by the Board and the collected funds are turned into the District to be managed by the Treasurer.) "Student fund-raising" also includes giving away goods or services, but suggesting a monetary donation.

The Board will permit student fund raising in school or on school property or at any school-sponsored event only when the profit therefrom is to be used for school purposes or for an activity connected with the schools.

Fund raising by approved school organizations may be permitted in school by the Superintendent and principal. For any fund-raisers, including those operated by student clubs and organizations, parent groups, or boosters clubs, that involve the sale of food items and/or beverages to students that will be consumed on the school campus (any area of property under the jurisdiction of the school that is accessible to students during the school day) during the school day (the period from the midnight before, to thirty (30) minutes after the end of the official school day), the food items and/or beverages to be sold shall comply with the current USDA Dietary Guidelines for Americans and the USDA Smart Snacks in School nutrition standards, and also be consistent with requirements set forth in Policy 8550, Competitive Foods.

Student fund-raising by approved school organizations off school grounds may be permitted under administrative guidelines of the Superintendent.

Use of the name, logo, or any assets of the District, including but not limited to facilities, technology, or communication networks, is prohibited without the specific permission of the Superintendent.

Crowdfunding activities aimed at raising funds for a specific classroom or school activity, including extracurricular activity, or to obtain supplemental resources (e.g., supplies or equipment) that are not required to provide a free appropriate public education to any students in the classroom may be permitted, but only with the specific approval of the Superintendent.

All crowdfunding activities are subject to AG 6605.

Third-party fundraisers that utilize email, social media, etc., are strictly prohibited.

Fund raising by students on behalf of nonapproved organizations outside the schools may be permitted on school grounds by the Board or designee and off school grounds by the Board.

The Superintendent may establish administrative guidelines for the solicitation of funds which shall:

- A. specify the times and places in which funds may be collected;
- B. describe permitted methods of solicitation which do not place undue pressure on students;
- C. limit the kind and amount of advertising for solicitation.

#### BoardDocs® PL

Advisors for approved school organizations shall not accept any form of compensation from vendors that might influence their selection on a vendor that will provide a fund-raising activity or a product that will be sold as a fund-raiser. Furthermore, advisors for approved school organizations shall not accept any compensation from a vendor after a decision has been made regarding a fund- raising activity or a product that will be sold as a fund-raiser. In addition, advisors for approved school organizations who make the selection of a vendor that will provide a fund-raising activity or a product that will be sold as a fund-raiser shall not enter into a contractual arrangement whereby an advisor receives compensation in any form from the vendor that provides a fund-raising activity or a product that will be sold as a fund-raiser.

Such compensation includes, but is not limited to, cash, checks, stocks, or any other form of securities, and gifts such as televisions, microwave ovens, computers, discount certificates, travel vouchers, tickets, passes, and other such things of value. In the event that an advisor of an approved school organization receives such compensation, albeit unsolicited, from a vendor, the individual shall notify the Treasurer, in writing, that s/he received such compensation and shall thereafter properly transmit said compensation to the Treasurer at his/her earliest opportunity.

The principal shall distribute this policy and the rules which implement it to each student organization granted permission to solicit funds.

#### MASTER SERVICES AGREEMENT

#### between Specialized Education of Ohio, Inc. and Wapakoneta City Schools for RSY of 2024-2025 at High Road School of Lima

This Master Service Agreement is dated August 1st, 2024 ("Effective Date"), between Specialized Education of Ohio, Inc. ("SESI") that owns and operates High Road School of Lima, an approved nonpublic, private special education school in Ohio and Wapakoneta City Schools, 1102 Gardenia Dr., Wapakoneta, Ohio, 45895, United States (referred to herein as "District," even in instances where the counterparty refers to itself as "Board") ("Agreement").

WHEREAS, SESI owns and operates High Road School of Lima that serves students with a wide range of special education classifications, primarily students with emotional disabilities and students with multiple disabilities (the "School"); and

WHEREAS, the District desires to refer District students to the School whose Individualized Education Plan ("IEP") have identified the Program as an appropriate placement (each a "Student"); and

WHEREAS, this parties have agreed to enter into a master set of terms and conditions that will govern the Services (defined below) as outlined in each student enrollment form.

#### WITNESSETH

NOW, THEREFORE, in consideration of the covenants contained herein, the parties agree as follows:

- 1. <u>Services</u>. The District may from time to time refer students to be enrolled in the School (hereinafter referred to as "Student" or "Students") as set forth herein.
- Term and Termination. The term of this Agreement will begin on the August 1st, 2024 and end on the July 31st, 2025 unless otherwise extended in writing by the parties ("Term"). Either party, upon thirty days written notification to the other party, may terminate this Agreement. SESI will be paid for any and all services delivered through the Termination Date.
- 3. <u>Distance Learning</u>. When due to government mandated closures or unforeseen circumstances that prevent SESI from conducting in-person classes, SESI may deliver the Services, in whole or in part, via distance learning to the extent practicable, using programs, systems, teaching techniques, diagnostic tests, evaluation, academic courses and materials adapted for distance learning at the level of service reasonably practical under the same circumstances, at the fees, rates and payment schedules as set forth in this Agreement.
- 4. <u>Enrollment of Students in the Program</u>. Upon a student referral by the District, the District will provide SESI with an established Functional Behavioral Assessment ("FBA") & Behavior Intervention Plan ("BIP") or provide an FBA and BIP within thirty (30) days if student is approved by SESI for enrollment in Program. SESI will evaluate each District-referred student (including but not limited to the student record, IEP, student observations, and Program visits) and determine whether the Program can meet the needs of the student as outlined in the student's current IEP, FBA and BIP. After such evaluation, SESI has final discretion to

determine if a student is accepted into the Program and may decline acceptance by providing written notification to the District of its reason(s) for decline. Upon acceptance by SESI of a student into the Program, such student's placement must be initiated by written notice from the District and SESI will agree on a commencement date for each student. To the extent SESI determines a Student's placement is no longer in the best interest of the Student after enrollment in the Program, SESI will notify District in writing and the parties will convene a meeting within thirty (30) days of SESI notification to discuss student transition and alternate placement.

- 5. <u>General Supervision of Services.</u> The District or its designated representatives shall have the right to general supervision of the Services, the right to approve such Services and the right to make changes to the Services in accordance with the terms of a Student's IEP. SESI will maintain records of the Services provided to the Students, invoices issued to the District and payments made to SESI during the term of this Agreement. Such records shall be consistent with any guidance or standards developed by the Department of Education. SESI shall allow the District or the Ohio Department of Education to conduct announced and unannounced site visits and to review all documents relating to the provision of special education services to the Students during hours that are least disruptive to the daily operation of the School.
- 6. <u>Fee.</u> In consideration of the Services to be provided by SESI, the District will pay SESI the fees set forth on Schedule 1 (collectively with Related Services (defined below) referred as "Tuition"). The Studentspecific services listed on Schedule 1 are pursuant to the requirements set forth in each Student's IEP ("Related Services"). If the Related Services change during the Term, the Related Services fees charged by SESI will automatically change upon approval of the revised Student IEP by the District and Student parent/guardian.
- Invoicing and Payment. SESI will invoice the District monthly by the 15<sup>th</sup> day of the following month in which Services were provided. All invoices are due and payable within thirty (30) days of receipt. The District agrees to pay SESI the Tuition during the Term regardless of the actual attendance of the Student.

During the 2024-2025 School Year, the District agrees to pay Provider a monthly education fee in accordance with Tuition listed on Schedule 1.

- 8. <u>Compliance with Applicable Laws</u>. SESI represents it complies with applicable laws and regulations governing the Services including student privacy laws including the Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99). The School is non-public and maintains licenses and certifications as required by Ohio law. SESI employees have the requisite skill, expertise and knowledge necessary to perform the Services required under the terms of this Agreement.
- 9. <u>Background checks</u>. SESI employees who are assigned to perform the Services meet the hiring requirements for school-based employees as required by applicable state laws and regulation.
- 10. <u>Student Progress Reports.</u> SESI shall make available to the District or its representatives those progress and evaluative reports upon request or as required by a Student's IEP.
- 11. Force Majeure. Neither party will be liable to the other party hereunder or in default under this Agreement for failures of performance resulting from acts or events beyond the reasonable control of

such party, including, by way of example and not limitation, acts of God, disease outbreak or widespread illness, electronic computer virus, civil disturbances, war, and strike.

12. Indemnification and Limitation of Liability. To the extent permitted under law:

a. District agrees to indemnify SESI and its officers, directors and employees ("SESI Indemnitees") against and from Claims (defined below) asserted by third parties for direct costs, expenses (including reasonable attorney's fees), damages, injury or loss ("SESI Losses") to which SESI may be subjected by reason of gross negligence or willful misconduct of District, its officers, directors or employees; provided however, SESI Indemnitees may not seek indemnification from District for any SESI Losses caused, in whole or in part, by the acts or omissions of SESI, its officers, directors and employees;

b. SESI agrees to indemnify District and its officers, directors and employees ("District Indemnitees") against and from Claims (defined below) asserted by third parties for direct costs, expenses (including reasonable attorney's fees), damages, injury or loss ("District Losses") to which District may be subjected by reason of gross negligence or willful misconduct of SESI, its officers, directors or employees; provided however, District Indemnitees may not seek indemnification from SESI for any District Losses caused, in whole or in part, by the acts or omissions of the District, its officers, directors and employees.

c. Claims. If a claim for indemnification (a "Claim") is to be made by a party entitled to indemnification hereunder against the indemnifying party, the party claiming such indemnification shall give written notice (a "Claim Notice") to the indemnifying party as soon as practicable after the party entitled to indemnification becomes aware of any fact, condition or event which may give rise to damages for which indemnification may be sought under this Section. Such Claim Notice shall specify the nature and amount of the Claim asserted, if actually known to the party entitled to indemnification hereunder. Subject to the limitations of this Section, the failure of any indemnified party to give timely notice hereunder shall not affect rights to indemnification hereunder, except to the extent that the indemnifying party demonstrates actual damage caused by such failure.

d. Notwithstanding any other provision, the total liability of SESI for all claims under this Agreement is limited to the total amount of fees paid to SESI under this Agreement. Neither SESI nor the District shall in any event be liable for any indirect, consequential, or punitive damages, even if SESI or District have been advised of the possibility of such damages.

- 13. <u>Disputes and Investigations</u>. In the event that any action, suit, proceeding or investigation relating to this Agreement is commenced, the parties hereto agree to immediately notify each other in writing of the pending action, suit, proceeding or investigation, and to cooperate to the extent possible to defend against and respond thereto and make available to each other such personnel, witnesses, books, records, documents or other information within its control that are reasonably necessary or appropriate for such defense. In the event any dispute arises out of this Agreement, the parties will seek to resolve the dispute as expeditiously as possible. Except as may be set forth herein, the interests of the referred Student shall be of the foremost concern in resolving such disputes.
- 14. <u>Assignment.</u> No assignment of this Agreement or of any duty or obligation or performance or payment hereunder, shall be made by either party, in whole or in part, without the prior written consent of the

other party, which consent shall not be unreasonably withheld, except that SESI may assign this Agreement or any duty or obligation or performance or payment hereunder to a subsidiary or affiliate of SESI or any entity acquiring all or substantially all of the stock, equity or assets of SESI.

15. <u>Notice</u>. Any notice required to be given under this Agreement shall be in writing and shall be duly served when it is (i) hand delivered to the addresses set out below, (ii) deposited, duly registered or certified, return receipt requested, in a United States Post Office, or (iii) via overnight delivery, to the party at the following addresses:

Any party may designate a different address by giving the other party thirty (30) days prior written notice in the manner provided above.

- 16. Governing Law. This Agreement shall be construed, interpreted, and governed by the laws of Ohio.
- 17. <u>Student Lunch.</u> When the District has an enrolled student in an out-of-District placement, the District remains responsible for ensuring that lunches are available to the student even if the approved special education school does not participate in the National School Lunch Program. The same principle of access to meals applies if a student with disabilities would have been eligible to participate in a school breakfast program at the school the student would have attended if the student had not been placed out-of-District. Documentation related to free or reduced-price meal benefits, including meal benefit applications, must be maintained by the District or approved private special education school claiming meal reimbursement. Approved private special education schools and collaboratives will review the free and reduced lunch student list with the District annually including the availability of meals to students who are publicly funded and placed at their facilities. If a school does not provide access to meals, approved special education school or collaborative leaders must contact the District to discuss arrangements that may be made to meet their mutual responsibility.
- 18. Independent Contractor. The relationship between the District and SESI shall be that of principal to independent contractor, and the employees of one shall not be deemed employees of the other for any purpose whatsoever. Each party shall maintain during the term of this Agreement such disability and worker's compensation insurance for its respective employees and staff as is required by law. Each party shall indemnify and hold harmless the other against any claim or demand made by employees or staff of the indemnifying party against the other based on rights or privileges applicable to employees of the other. Each party shall be solely responsible for the hiring, training, and termination of its own employees and contractors.
- 19. <u>Entire Agreement</u>. This Agreement includes all exhibits, schedules, attachments attached hereto are incorporated herein by reference. This Agreement constitutes the entire agreement between the parties and supersedes all prior and contemporaneous oral and written agreements and statements, all of which

have been fully integrated herein. This Agreement also supersedes any course of conduct, performance or dealing between the parties. No amendment or modification changing this Agreement's scope or terms shall have any force or effect unless executed and delivered in writing and signed by all parties.
